WHEREAS, The Erie County Legislature seeks to honor individuals and institutions of Erie County who enhance the quality of life in the community through their efforts; and

WHEREAS, *Chestnut Ridge Park* consists of 1,213 acres of park land, named after the Chestnut Trees on its hills. *Chestnut Ridge Park* was one of the first parks established by Erie County in 1926, and is the largest park operated by the Erie County Department of Parks, Recreation and Forestry; and

WHEREAS, *The Chestnut Ridge Conservancy* was formed in 2010 to support the restoration and preservation of the rich natural, recreational, and historic resources that comprise *Chestnut Ridge Park*; and

WHEREAS, *The Chestnut Ridge Conservancy* members volunteer and raise money to assist various park events and projects including the annual youth fishing clinic, the Blue Star Memorial Byway marker, Santa Land and Winterfest, and the Eagle Scout Project to restore bleachers at the baseball diamond, among other events; and

WHEREAS, *The Chestnut Ridge Conservancy* has worked together with the county and other groups to improve the park in many ways including the installation of a wildflower garden, tennis court wind screens and benches, pet waste collection stations, memorial benches, fishing pier, long-range binoculars, casino mural restoration, park signage, extensive stone work restoration, casino floor refinishing, and more.

NOW, THEREFORE, BE IT RESOLVED, the Erie County Legislature pauses in its deliberations to honor and recognize members of *The Chestnut Ridge Conservancy* for protecting and improving the treasure of *Chestnut Ridge Park* to be enjoyed for generations.

About the Conservancy, it's beginnings, and its future...

In an effort to assist the County of Erie in preserving and restoring Chestnut Ridge Park in the midst of budget cuts and rising expenses, a dedicated group of concerned citizens came together in 2008 to form the Chestnut Ridge Conservancy.

Officially incorporated in 2010 as a not-for-profit 501(c)(3) organization the Conservancy was established to support the restoration and preservation of the rich natural, recreational and historic resources that comprise Chestnut Ridge Park.

The Conservancy is a all volunteer organization comprised of a non-paid Board of Directors. The members of the Board work in partnership with Erie County Department of Parks, Recreation and Forestry through a legal Memo of Understanding with Erie County. The Conservancy's funding stream is based on memberships, general donations and a once a year Gala fund raiser. Through the past ten years the Conservancy has accomplished some very notable achievements for Chestnut Ridge Park. See our achievements page.

As is the case with most not-for-profit organizations, funding new initiatives big or small remains a challenge. Today's Park perseveration and restoration projects whether they are big ones or smaller ones, cost a lot of money. Even simple stone work restoration can run into the tens of thousands of dollars.

The Conservancy remains committed to continue as a viably funded organization, to utilize its resources to help with occasional calling from the Erie County Parks Department on various restoration or preservation projects. Community support is essential for the Conservancy to remain as a viable funded organization.

Chestnut Ridge Conservancy Formed to Revitalize Park

Volunteer group will help fundraise and identify projects to enhance park

Erie County Executive Chris Collins and County Parks Commissioner Jim Hornung welcome the opportunity to work with a group of volunteers who are forming the Chestnut Ridge Conservancy. This association of volunteers came together with the specific purpose of revitalizing Chestnut Ridge Park. The new group held its first fundraising party in the Chestnut Ridge Casino tonight.

This is a different model than the Olmsted Parks Conservancy. The Chestnut Ridge Conservancy will be focused on fundraising, and identifying possible projects to improve the park, with the guidance of the Erie County Parks Department. The County will continue to handle all maintenance and day to day operations of the park.

Parks Commissioner Jim Hornung said, "We're thrilled that Erie County residents are taking an active role in beautifying one of our County parks. Chestnut Ridge holds a tremendous amount of historic architecture in bridges and shelters. This group will help us preserve those structures. While government agencies across the nation deal with budget constraints, it's nice to see citizens step in and help ensure their parks remain in the best condition possible."

"Chestnut Ridge is the largest County park in the United States and is graced with stunning views, extraordinary natural beauty and unique rustic architecture," said Conservancy Member Marilyn Heim. "The vagaries of the past few years have left our Park in a state about which none of us can be pleased. With the enthusiastic support of our County Department of Parks, we have begun this venture to rebuild and revitalize our Park."

If the Chestnut Ridge Conservancy is successful, it may serve as a model to develop conservancies for other County parks in the future.

Excerpts from Erie County Park Commission booklet published 1939

“South easterly from Buffalo there is a gradual rise towards the foothills of the Allegheny Mountains in Pennsylvania. The first sharp rise in this direction from the gently sloping basin which surrounds Buffalo at the foot of Lake Erie has an elevation of about 1200 feet. It is about seven miles inland from Lake Erie. One of these ridges swings westerly to merge in the uplands on the eastern side of the Eighteen Mile Creek valley which extends southward. Along the crest of this ridge Erie County pioneers found many enormous chestnut trees and ever since that time, this section, as been known as Chestnut Ridge”

. With an overlooking panoramic vista of Lake Erie, the City of Buffalo, Village of Orchard Park and other towns now sits Chestnut Ridge Park, the crown jewel of Erie County's Park System.



Chestnut Ridge Park consists of 1,213 acres of park land, originally named for the chestnut trees on its hills, it is currently the largest park operated by the Erie County Department of Parks, Recreation and Forestry. The Park property was acquired by Erie County in 1926, and it was one of the first parks established by the County. The park's facilities and landscapes were improved substantially by the Works Progress Administration throughout the 1930s. The Park lands include some of the most beautiful natural scenery and vistas to be found anywhere in Western New York.

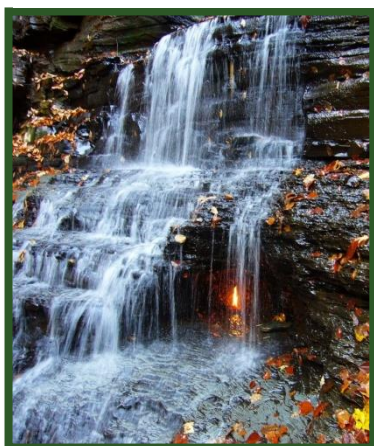

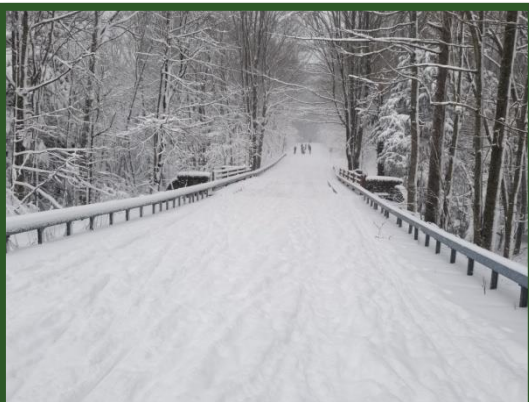


Things to see and do in Chestnut Ridge Park
