THE BATTLE OF CHESTNUT RIDGE

Civil War Reenactment Comes to Chestnut Ridge Park August 25 - 27, 2017

The Chestnut Ridge Conservancy and the Erie County Department of Parks, Recreation and Forestry are proud to present a Civil War reenactment at Chestnut Ridge Park later this summer. The public is cordially invited to attend this fascinating, family-friendly weekend event which we are calling *The Battle of Chestnut Ridge*.

Members of the 49th New York Reenactors, under the direction of Colonel Mike Lavis, are working with the Conservancy's board led by directors Liz Cash and Toni Cudney, along with Parks Commissioner Dan Rizzo, Parks Supervisor J. J. Thomas, and the county park rangers and staff to organize this event. It is the first time a Civil War reenactment will be held in an Erie County park.

Blasdell resident Lavis is thrilled to be organizing and participating in the event at Chestnut Ridge. He expects approximately 300 reenactors from New York, Pennsylvania, Ohio, and Canada to participate in the reenactment of the South Mountain Campaign which occurred in Maryland on September 14, 1862.

Everything will take place on the Newton Road side of the park. Free shuttles will be available from the parking areas to move park guests to and from the battlefields and encampments.

There is a full slate of events scheduled for the weekend. In addition to two battles on Saturday (one in the afternoon and one near dusk), the reenactors will be in the park most of Sunday to

talk with spectators. There will be lectures on life in 1862 and Civil War medicine, presentations on Robert E. Lee and key players from both sides, and other information about the “war between the states.”

The Conservancy has established an entire web site dedicated to this great educational event. It includes the official schedule of events, historical maps, photographs and descriptions about the South Mountain Campaign, a dedicated mailing list to keep you informed, and helpful tips for both reenactors and spectators regarding parking and maneuvering around the park that weekend. The seller was located in California. He had purchased the picture at a Florida flea market and expressed his desire to find a buyer in Erie County.

Bill purchased the framed photo, autographed by all six commissioners with the original plaque, for \$38. It was presented to John Bailey at our 7th Annual Meeting in appreciation for his years of service to the Conservancy. After a 93-year journey, this historic photo has finally found its way home.
