## The Chestnut Ridge Conservancy

- In an effort to assist the County of Erie in preserving and restoring Chestnut Ridge Park in the midst of budget cuts and rising expenses, a dedicated group of concerned citizens came together in 2008 to form the Chestnut Ridge Conservancy.
- Incorporated in 2010 as a not-for-profit 501(c)(3) organization the Conservancy was established to support the restoration and preservation of the rich natural, recreational and historic resources that comprise Chestnut Ridge Park.
- The Conservancy is a all volunteer organization comprised of a non-paid Board of Directors. We work in partnership with Erie County Department of Parks, Recreation and Forestry through a Memo of Understanding with Erie County.
- Our funding stream is based on memberships, general donations and a once a year Gala fund raiser.

# 2020 Community Outreach Events

- The Chestnut Ridge Conservancy also plays a role in bringing people to the park for various events and recreational happenings.
- Due to the 2020 COVID restrictions, many of the CRC outreach events were unfortunately not held, except for the 2020 Chestnut Ridge Summer Classic Tennis Tournament which brought in a record number of participants as Tennis was deemed a safer outdoor sport to play.
  - 2021 however, is once again a less restricted year and the Conservancy will be engaging in it's sponsorship of the 2021 Summer Classic Tennis Tournament, The Orchard Park Art Festival, The Kite Festival, Movie Night in the Casino in December, SantaLand at the Casino and WinterFest.

2020 Park Restoration & Improvement Projects CARLEN DE L'ANDER Despite the limited activity in 2020, the Conservancy still accomplished the funding and replacement of the upper four tennis courts lighting fixtures at a cost of \$27,000. After twenty five years of no lights, the tennis courts finally have state of the art 500 watt LED fixtures illuminating the upper four tennis courts with extra hours of tennis playing time for those Chestnut Ridge Park tennis enthusiasts.

- A playground for all children of all abilities to be located in Chestnut Ridge Park to the right of the Park Casino and set to be installed this August!
- The grand total price tag for the playground, base and excavation work is approximately \$770,000.
- This is a joint project we are working on hand in hand with Erie County Parks,
  Recreation and Forestry and would not be otherwise achievable!
- We have engaged with Wendel Architects and Rodriguez ConstructionCompany to do the architectural drawings and needed excavation work.
- The site excavation work is currently in progress and will be completed within the next two weeks.
- Parkitects, Inc. is the vendor providing the equipment and rubber base installation.
- August 3<sup>nd</sup>, 6<sup>th</sup> & 7<sup>th</sup> are the Community build days.

WHEREAS, The Erie County Legislature seeks to honor individuals and institutions of Erie County who enhance the quality of life in the community through their efforts; and

WHEREAS, Chestnut Ridge Park consists of 1,213 acres of park land, named after the Chestnut Trees on its hills. Chestnut Ridge Park was one of the first parks established by Eule County in 1926, and is the largest park operated by the Erie County Department of Parks: Recreation and Forestry, and

WHEREAS, The Chestnut Ridge Conservancy was formed in 2010 to support the restoration and preservation of the rich natural, recreational, and historic resources that comprise Chestnui Ridge Park, and

WHEREAS, The Chestnut Ridge Conservancy members volunteer and raise money to assist various park events and projects including the annual youth fishing clutic, the Blue Star Memorial Bywey uparker, Statu Land and Witterfest, and the Eagle Scatt Project to restore bleachers at the baseball diamond, among other events, and

WHEREAS, The Chestanuk Ridge Conservances has worked agebone with the county and other groups to improve the park in many ways including the installation of a wildflower garden, tennis court wind screen and borches, pet witste collection stations, memorial benches, fishing pier, longerange bineculars, canno mural restortion, park signage, extensive stone work restortantic, resisto (low refishing, and mare
